Our annual State Convention for this Fraternal Year is now in the past. I wish to thank those members from across the state who were able to join us. I know I met some new Brothers and I hope others did as well. As the saying goes "There were no strangers there—only some Brothers who may not have yet met one another." Oregon has yet to reach our assigned goal but credit can be given for "strengthening the foundation" and performing activities that are leaving a Knight of Columbus Footprint. As the Fraternal Year enters the final lap, I wish to note some activities that are or will

strengthen our "basic foundation," leave a Knights Footprint and grow the Order in Oregon.

The Activity to acquire a container of **wheel chairs** for use throughout the state is occurring, but we need to expand our perspective outside our own Council or parish borders and try to reach out to others in the community who could use a chair. (My special thanks to Kent Purdy who has been pursuing this activity).

Districts joining together for their District meetings and training will expand our brotherhood fraternity.

Are your activities known? Are they in the Parish Bulletin? We need to get a higher grade on our Report Card with the subjects of publicity and reporting!! IT'S "OK" to pat yourselves on the back!!

I want to thank all of you for all your hard work and dedication to the Catholic faith and making your Community, Family and the Knights of Columbus in Oregon better. The Knights of Columbus in Oregon changes lives and saves lives because of you and your Councils. The State would never achieve each individual goal, and the Parishes in the Portland and Baker Dioceses would be lacking help and resources without your Councils, so kudos to all of you.

At the 111<sup>th</sup> State Convention in Lebanon I shared my vision to all the delegates for the Knights of Columbus in the State of Oregon for the upcoming year.

For us to have that voice in the State of Oregon I'm asking for your help to increase new membership in the state by 550, achieve \$1 million in charitable contributions and 1 million Knight Hours.

I would like to see Councils participate in Districtwide Polar Plunge Teams throughout the State of Oregon to increase our visibility and presence to help raise money for the Special Olympic athletes. It will be great to present a challenge to see which District will have the most participants.

I would like all Councils to participate in one of the following Youth programs: Coats for Kids, Soccer Challenge or the Free-throw Contest.

Also, most Councils already participate in the Food for Families and I encourage other Councils to do the same.

So I have asked Alex Paul (Sweet Home Council) to take over as the Public Relations Chairman. All the Grand Knights, District Deputies, State Directors and Chairmen need to call, text or email Alex on what programs your Council is doing so he can have it published to your local paper and Catholic Sentinel.

It's going to be a momentous year my dear Brothers and I am looking forward in seeing your Council's successes and watching our Order reach the 10,000-member mark.

#### May Challenge by Supreme Chaplain

Jesus said, "My children, I will be with you only a little while longer.

I give you a new commandment: love one another.

As I have loved you, so you also should love one another" (Gospel for May 19, Jn. 13:34).

"I give you a new commandment: love one another," we hear in the Gospel reading. We've heard this saying of Jesus before, but do we personalize it this and truly know it to be true? Statistically, we as Catholics in America today are not renowned for loving one another to the point that we risk sharing our faith with others. One recent poll found that only 6% of Catholics characterized sharing their faith as a "high priority." But Jesus invites us to do more. He does not call the equipped; he

equips the called. And each one of us is called to love one another in the most profound way—by caring about others' eternal well-being.

#### Challenge by Supreme Chaplain Archbishop William E. Lori:

Either way, be welcoming and nonjudgmental when they give their response.



#### **Culture of Life**

Patrick and Teresita Parson Life Couple - Oregon Knights of Columbus

What does it take to be a defender of life? In addition to wanting to protect life, a defender must also be willing to accept being accosted for his beliefs. You may have seen a video where a Pennsylvania state representative bullied a woman who was standing a prayer vigil outside an abortion center in Philadelphia. That lone representative vilified the woman, calling her names while she walked up and down the sidewalk praying her rosary. Elsewhere, at least two physical assaults were made on pro-life supporters this spring in California and Kentucky. Most participants in 40 Days for Life (including Teresita and myself) have undergone obscene shouts and gestures from passerby holders of differing viewpoints.

So why continue to expose ourselves to public abuse? The answer is as simple as reading a Bible verse, more specifically, Proverbs 24:11-12 / "Did you fail to rescue those who were being dragged off to death, those tottering, those near death, because you said, 'We didn't know about it'? Surely, the Searcher of hearts knows and will repay all according to their deeds." Another illuminating passage of Scripture is from James 4:17 / "So for one who knows the right thing to do and does not do it, it is a sin." We know the right thing for ourselves is to take an unpopular stand in defense of life.

Oregon House Bill 2217 (which expands ways in which lethal medication can be taken) has been scheduled for a public hearing and work session on May 9 at 8:30 am in the Senate Judiciary Committee, Hearing Room C. Another euthanasia bill (Senate Bill 579) is still active and may be scheduled for a vote of the full Senate soon. Tell your senator to vote "NO" on both bills.

Finally, congratulations to all Councils who were recognized for their efforts in the Life field. St. Elizabeth Anne Seton Council 16482 received the Division 3 award, St. Patrick Council 3484 of Canby received the Division 2 award, and Albany Council 1577 received the Division 1 award. Supreme Life Award was co-awarded to St. Joseph Council 1748 of Salem and Our Lady of the Lake Council 3818 of Lake Oswego for working together to obtain 2 ultrasound units for Hope Pregnancy Clinic in Salem. Thank you for all your efforts!

#### Cultura de la Vida

¿Qué nos quita ser defensores de la vida? En adición también proteger a la vida, un defensor también debe de ser abordado por sus creencias. Tal vez ya vieron un video reciente en el que un representante de la casa de Pensilvania se burlaba de una mujer que estaba en vigilia de oración afuera de una institución abortiva de Filadelfia. El Representante vilipendiaban a la mujer diciéndole palabrotas, mientras ella iba caminando por la calle arriba y abajo, y orando su rosario. De cualquier manera, 2 asaltos al menos se llevaron a cabo esta primavera en California y Kentucky. Tu dirás después ¡No lo sabíamos!, pero el que pesa los corazones ve claro, el que te observa lo sabrá; y recompensará a cada uno según sus obras. Otro pasaje muy iluminado es la escritura de Santiago 4:17 "Quien sabe que es lo correcto, y no lo hace, comete un pecado." Sabemos que lo correcto para nosotros es hacer cosas no populares, en Defensa de la vida".

La Cuenta de la casa de Oregon 2217 (que expande caminos en la que los medicamentos letales se suministran) se calendarizaron para ser escuchados públicamente en sesión de trabajo el 9 de Mayo a las 8.30 a.m. en el Comité del Senado Judicial, en el salón para escuchar C. Otra cuenta de Eutanasia (Cuenta del Senado 579) sigue activa y tal vez se calendarice para voto por el senado completo muy pronto. Dile a tu Senador que votas "NO" en ambas cuentas.

Finalmente felicitaciones al consejo que fue reconocido por sus esfuerzos en los terrenos de la Vida, St. Elizabeth Anne Seton Council 16482 recibiendo el 3er premio. El consejo de St Patrick 3484 de Canby recibió premio en 2º lugar, y el Consejo de Albany 1577 recibió el 1er premio. El premio supremo de la vida fue compartido en St Joseph Council 1748 de Salem, y Nuestra Señora del Lago de el Consejo 3818 de Lake Oswego por trabajo juntos para obtener 2 ultrasonidos para el Centro de embarazo Hope en Salem. ¡Muchas gracias por todos sus esfuerzos!

#### Patriotism, Our Flag and Our Church

As Knights of Columbus, we aspire to live by four core **principles**: Charity, Unity, Fraternity and Patriotism. The principle associated with the Fourth Degree is Patriotism. During my recent Fourth Degree Exemplification, I was most stirred, and inspired, by the emotions displayed by each of the candidates as the ceremony proceeded. In subsequent discussions with several Knights, the question of the patriotism of clergy and church hierarchy was questioned. An example is perhaps the lack of, or the way in which the U.S. Flag is displayed.

Per the Knights of Columbus official website, the statement on patriotism reads: "Members of the Knights of Columbus, be they American, Canadian, Mexican, Cuban, Filipinos, Poles, or Dominicans, are patriotic citizens. We are proud of our devotion to God and country and believe in standing up for both. Whether in public or private, the Knights remind the world that Catholics support their nations and are amongst the greatest citizens."

In traveling to Catholic churches around our country, one can see the American and Papal Flags sometimes displayed in the nave, sometimes in the vestibule, sometimes less noticeable in a corner, and sometimes not displayed at all. Per the United States Conference of Catholic Bishops website there is minimal guidance offered as to flag placement. "Surprisingly to many, there are no regulations of any kind governing the display of flags in Roman Catholic Churches. Neither the Code of Canon law, nor the liturgical books of the rite comment on the practice. As a result, the question of whether and how to display the American Flag in a Catholic Church is left up to the judgement of the diocesan bishop, who in turn often delegates this to the discretion of the pastor.

The U.S. Conference of Catholic Bishops has in the past encouraged pastors not to place the flag within the sanctuary itself, in order to reserve that space for the altar, the ambo, the presidential chair and the tabernacle. Instead the suggestion has been made that the American flag be placed outside the sanctuary, or in the vestibule of the church together with a book of prayer requests. It remains, however, for the diocesan bishop to determine regulations in this matter."

Title 4, United States Code, Chapter 1 states, "When displayed from a staff in a church or public auditorium, the flag of the United States of America should hold the position of superior prominence, in advance of the audience, and in the position of honor at the clergyman's or speaker's right as he faces the audience. Any other flag so displayed should be placed on the left of the clergyman or speaker or to the right of the audience." Placing the Flag in the vestibule or in a corner is not placing the Flag in a position of superior prominence.

As a note, placing our Flag in a position of prominence in our church also pays tribute to clergy who have served or are currently serving our country and all other Catholics who have served as well. How many of us know the heroics of Lt. John Washington (one of the 4 chaplains on the USS Dorchester) or Medal of Honor winners Fr. Vincent Capodanno, Fr. Emil Kapaun, Fr. Joseph O'Callahan and Fr. Charles Water or Fr. Francis Sampson, who received the Distinguished Service Cross and became part of the inspiration for the film, Saving Private Ryan. Many Catholics have proudly served our God and country, with some paying the ultimate sacrifice.

Why isn't the American Flag more honorably displayed in many of our churches? In my own church, I was told displaying the flag in the nave may be considered a distraction or that it would violate the 1st Amendment Separation of Church and State. Neither comment is valid. Having the flag prominently displayed reminds us of our Catholic civic duties to God, church and country.

The 1<sup>st</sup> Amendment was written to keep our government from controlling churches. When entering a church with an American flag prominently displayed, it helps reinforce my belief that we are American Catholics and have a responsibility to God and country. Though I recognize the flag, I am there to worship our God and find no distraction. Though often cited, the words designating the "separation of church and state" are not included in the 1<sup>st</sup> Amendment to the Constitution. The Amendment states that Congress "shall make no law respecting the establishment of religion or prohibiting the free exercise thereof". This dealt with prohibiting the establishment of ONE church by law, or that any of the citizen's religions were going to be proscribed.

Knights of Columbus begin our meetings with a prayer and the Pledge of Allegiance. In school, our children say the Pledge of Allegiance, which includes the phrase "One nation, under God". Our coinage includes the phrase "In God We Trust". Our presidents are sworn into office using the bible. Religious Chaplains are members of the US military and provide religious services and sacraments. When on ship, I often led religious services if a chaplain was not present. Again, I would propose that it is important that the U.S. Flag be present as a reminder to Catholic parishioners that we all have a responsibility to God and country. Atheists and agnostics continue to chip away at the influence of religion in our civil society. They desire to remove any reference to God on our coinage and in the Pledge of Allegiance. They have fought to remove any reference to prayer in public school and have removed religious symbols from "holiday" (was Christmas or Easter) celebrations. Abortion and divorce are the law of the land, as is assisted suicide in in several states. Out of wedlock births are common. We now must teach "secular" ethics in professional schools. As participation in churches is declining, parishioners need to be ever more attentive to their respective civic duties to both God and country.

We need to respect our flag, embrace patriotism, continually strive to love our God and church, and ensure our country follows the principles upon which it was founded. The presence of our flag in our church reminds us of that very special God-country connection. We pray and work to end abortion, strengthen and support families, preserve the sanctity of marriage, honor prayer in public and teach our children patriotism. If we "cocoon" ourselves, and do not strive to insert our values in society we will lose the values we are trying to instill in our children. We ARE Roman Catholics AND citizens of the United States of America. Many parishioners could probably identify the Knights' works of Charity, Unity and Fraternity, but how many are able to identify Patriotism as one of our core principles? It is up to us as Knights to actively embrace this principle and enlighten our bishops and pastors as well.

The flag is one of the most visible signs of a country and many Catholics have proudly served under our flag and for our country. Let us display it with pride!

## **Hispanic Outreach Coordinator**

2019 State Convention

"Come Holy Spirit"

Always good to see all those friendly faces to match with the familiar voices I hear throughout the year. Time goes by so fast that another year goes by and it's time to train another set of State leaders

with their new positions. My total evaluation for this Knights of Columbus Convention of fraternal year 2018/2019 is very good. Lots of accomplishments were realized and a giant step forward was made by all. A little gray cloud showing some "politics" in the air which is the result of election times but other than that, it was a great meeting.

First, I would like to thank all the Grand Knights who opened their Council doors to our Hispanic brothers. The recruitment of Hispanics is alive and active. Hearing this type of news is always music to my ears. The number of interested Hispanic brothers wanting information of the Knights of Columbus is growing rapidly and more requests for help are coming in from different directions of the state. Get those Round Table Program active and put them into practice!

The weekend of May 11<sup>th</sup> and 12<sup>th</sup>, there were two Admission Degrees, one in Salem at St. Joseph's and one at St. Vincent. St. Joseph already has their own Spanish Council, San Jose and now St. Vincent is receiving almost 20 new candidates with their first Spanish First Degree. Thanks to Council 1577 in Albany for providing the First Degree Team.

While at the Convention, I had requests from Eugene, Prineville, and Grants Pass for informational sessions. This is the type of momentum I was hoping to see and hear about and that is why I now repeat part of the presentation I did at the Convention for those who might not have been there. However, I would like to share some precautions on the way this is applied:


- 1. Create or implement the Round Table Program if you have the potential to recruit Hispanics at your parish. The new booklet from Supreme "*Why join the Knights*" is available in Spanish and is very useful.
- 2. If you have Hispanic Brothers in your council, don't establish a direct path from the entrance Council door to the exit door by charging them the "initiation fee and annual dues" before they even sign the Form 100. Educate and also explain to them why annual dues are mandatory during the Round Table meetings. Don't scare them away before they even come in. Bad news travels fast.
- 3. Make extra efforts to invite them to your regular meetings by reminding them in multiple ways, in person, by phone or e-mail if necessary.
- 4. Establish a separate Round Table meeting day where non-members can attend and share information about current events. This really helps those who feel somewhat uncomfortable with the language issue and it will enhance their own recruitment efforts to bring in their friends.
- 5. Slowly introduce them to different projects or programs your Council might be working with and try to get them involved. Our Hispanic Brothers are hungry to participate in activities with the parish they attend. But they want to feel the need to be involved. (A great example is what Christ the King Parish in Milwaukie is doing with the new Hispanic members of their Council who volunteer their talents with a project outside the parish. Being of service to others is what the Knights of Columbus do.)
- 6. Do not rush our Hispanic Brothers into a position as a Council Officer before they learn or we teach them the duties and responsibilities. (Let us all learn to do one thing at a time and do it well.)

I would like to add one other observation: it seems we sometimes concentrate too much on the "Rules and Regulations" and not focus on what Father McGivney's Mission was and is today, "to be of service to others".

Seven, we who are called as Ambassadors of the Culture of Life and Civilization of Love, as messengers of His Mercy must be ... a people know for our rejoicing.

And Eighth, or lastly, but primarily, we who are called as Ambassadors of the Culture of Life and Civilization of Love, as messengers of His Mercy must be ... a prayerful people capable of uttering a profound "yes" to the intense and hidden work of grace in our souls.

We can participate most marvelously in God's work of grace by becoming the actual means of grace and mercy for those persons He is waiting to bring home: those young and not-so-young men and women who feel far from the Church of their Baptism; those men and women caught in sins against the gift of human love; those pregnant and threatened by life; those men and women who in desperation have sought death as a solution to the difficulties in life. It is our job to bring them home—one heart at a time—to the Heart of Jesus who thirsts for them.

Allow me to conclude with a wonderful little story I heard from Father Benedict, in which he told of a Friar's dream. "In the dream, the Friar was walking through a very dark wood. The weather was threatening and he was all alone and filled with foreboding feeling and an ominous sense. And as he walked through this forest, he carried a lighted candle, and knew somehow, the he must not let the light of the candle go out. This was rather difficult given the circumstances, for it was difficult to protect the flame against the wind and the rain and furthermore, the wax was dripping and burning his hands. He heard, as he walked on, a commanding voice say to him, 'Blow out your candle!' Yet, he knew he would not and could not, for he recognized that the candlelight was symbolic of his baptismal grace. The Friar kept walking deeper into the forest until he came to a clearing where the rain stopped and the winds subsided, and a calm returned to the forest. And then, standing in the light of the clearing, holding his candle, he began to see people emerge from behind the trees and approach him. They looked weary and disheveled, lacking in hope. Each came with a candle in his hand which had been blown out. One by one, each person approached the Friar and re-lit his candle, and together as a body enveloped by a glow of radiant light, they moved forward confidently.

You carry the grace to know the truth about God, and the truth of the dignity of the human person, the truth about God's plan for love and marriage. Never, never, never let that truth be extinguished in your heart by discouragement, by doubt, by despair, or by what may appear to be lack of success, for the world desperately needs your light.


