I just returned from the State Deputies Mid-Year Meeting. In spite of a crammed-filled weekend of new information, there were opportunities to experience some fraternal bonding among State Deputies and Supreme Staff, share ideas and leave inspired to move forward and finish strong this Fraternal Year!

Throughout the weekend there was continued emphasis of the **Faith in Action** Programs and about its importance on growing the order, strengthening parish community, involving families and that we all become stronger Catholic Role Models. It was an inspiring weekend. This State Deputy’s weekend coincided with the message we, State Officers, heard from Archbishop Sample at our annual luncheon with him a month ago. The topic of KofC Council relationships with Pastors was on the agenda. There was mutual understanding that a strong working relationship or foundation may not exist with every pastor. Brothers, it is obvious to me---it’s something we need to make happen **NOW!!** Now, here is the Archbishop’s message:

Clergy need to know we are there to support them, especially now. He referred to the Domestic Church Initiative as a great foundation and which has evolved to be our **Faith in Action** Programs. Some of his specific suggestions are these:

- How solid is the Council’s foundation with the Pastor? Even if you feel there is an existing and solid foundation, re-visit it. This could be done bi-monthly or quarterly, but don’t continue to take for granted that the foundation is completely solid.
- Someone from the Council needs to visit with the Pastor with the question: “How can we help you? How/what items on your full plate of duties can we help you with?”
- This may be the Grand Knight, another Council officer or someone who can serve as “contact” with the Pastor. It doesn’t have to be one of the Council elected officials.
- The approach **NEEDS TO BE how can we help you?** Do not begin your conversation with just the message that here are the Knight’s activities we want to do to help the parish.

**Let’s reach out Brothers!!** The message is loud and clear. The opportunity to develop **the Faith in Action** Programs is at our doorstep. We need to act **NOW** --- not next Calendar Year, not next Fiscal Year and not even next month. Why not this month?? **Why???**

What can you and your Council do with other groups in your parish to help revitalize the community atmosphere of your Parish? What can you and your Council do to invite other Catholic men to help be **“Laborers for our Father’s Vineyards?”**

**Merry Christmas!!** Frost on the north side of roofs the past two mornings was an awakening that the season to request your assistance and reserve highway billboard space is **NOW!!**

Keep Christ in Christmas Billboards are posted along the Highways of Oregon starting in November. I am attempting to rent a few "High Public Exposure" billboards for both November and December. According to statistics provided by the three billboard companies we used, these billboard sites provided nearly three million "viewing impressions." A "viewing impression" is defined as adults 18 years or older who passed by and could have seen the billboard image and/or message.

The view on the billboard is the Nativity scene (Joseph, Mary and the Christ Child) with the phrase "Keep Christ in Christmas", along with **10 inch bold letters** at the bottom indicating the sponsor is: "Oregon Knights of Columbus." Last year 22 Councils participated or 25%. **My Brothers can't we do better?** As Chairman, my goal is "involvement" i.e. every Council participating with some contribution. As Knights, we know the power of unity.

What might your Council or Assembly contribute? You can consider the range of contributions received past year which was \$50 to \$550. **All amounts help!**

From the Director's Desk

### New Programs to Form Basis for Renewal

The evil, crimes and sins recently revealed so publicly underscore the serious need for us to engage the spiritual battle raging around us. In his letter on August 20, 2018, Pope Francis summoned us to a solidarity in fighting "especially spiritual corruption." The Holy Father asked each of us to undertake "a personal and communal conversion that makes us see things as the Lord does" through prayer, penance and fasting.

During this time it may prove fruitful to use the "*Into the Breach*" document as a tool for prayer and discussion to identify how and where Brother Knights and other Catholic men can step into the breach now being experienced as such a wide rift in the Church.

To all of our good holy priests who have stood up and been fathers rather than politicians to those who are hurting, scared, despairing in these dark days — thank you. If this is this hard on lay people, I can only imagine how hard it is on faithful priests. As much as we criticize and rage at our church, let's make sure we spend more time praying for our priests."

As Chaplains, may we direct the charity of our Brother Knights toward prayerful solidarity with the victims of abuse and with all who are grieving and striving to combat the works of the Enemy within the Church. May Father McGivney intercede for each of us as we lay down our lives with Christ our Lord.

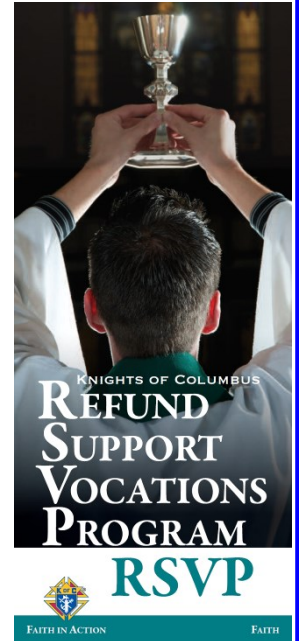

## **Fourth Degree Master Report**



This month my thoughts for the monthly newsletter are based on experiences from both sides of my duties with Knights of Columbus in Oregon - Hispanic Outreach Coordinator and District Master for the Fourth Degree.

First the great news regarding the recruitment of our Hispanic brothers into the Order of Knights: It's been a long, slow and uphill climb, both to open the large heavy doors to the Councils and the other to convince our Hispanic brothers that it's O.K. to join hands with the Knights of Columbus of Oregon. I had seen a lot of the Hispanics in areas I visited before such as Texas and California, but not here in Oregon.

I can't help but think how difficult it might have been for those "migrants" coming from Europe to this country looking for a better life for themselves and their families. The results are becoming more and more visible in all directions of the state. The largest flare came from the largest church in the diocese, St. Joseph in Salem. The first large group of Hispanics were initiated in December of 2015 with over 25 new members. That was kind of the big hit that put a crack on the dam holding the water gates. "Gracias Caballeros de Colon" from Concilio San Jose #16934, Salem, Oregon. Thank You to all Officers and members of that Council who have been very active and doing a lot of necessary work for their Parish, according to the Monsignor at San Joseph Parish in Salem.

My dream of seeing the Salem area establish the largest concentration of Hispanic Brothers as members of the Knights of Columbus might still become a reality in my lifetime!!!

This side of my story is becoming a great joy to me. I am so very grateful for all the Brother Sir Knights. My most sincere appreciations for all Assemblies that had Fourth Degree Exemplifications in their areas so far: Gresham, Klamath Falls, Hermiston and Tualatin. These four area Assemblies have brought in a total of 71 new Sir Knights into the Order of Patriotism this year. This small breeze of fresh air is starting to show the colors of our American Flag. Can you imagine what it would be like if we put similar efforts from all of the thirty-two Assemblies in the state? The results would be overwhelming.

I can imagine the excitement and privilege it was every time I read or review the brief history of the Fourth Degree when the first exemplification took place in New York in 1900 with 1,383 candidates. I can see the true colors of our American Flag and the significance of the courage of those Sir Knights stepping forward into the Fourth Degree. Renewing the promise of Patriotism has helped me be a stronger believer and grateful for the gift of freedom we have in this country.

The issue of the new uniform change no doubt had caused some minor disturbance amongst some of the Sir Knights and that's reasonable due to the method of how it was done by the higher authorities. Worthy Sir Knights, a similar issue took place during the infancy stage of the Fourth Degree when someone entitled "The Knights of Columbus in Uniform". One person, an editor of a Catholic paper, was "considerably disturbed" by the unconstitutional behavior on democratic grounds. It was presumed then, as it is presumed now, that others were listening? We all know that "change" is not always easy to make but the decision has been made and the sooner we accept it the sooner we will be moving forward in UNITY. Together as Proud American Catholics that we are. That's what we do!

Finally, my experience from these last four exemplifications is that the Fourth Degree has taken me beyond the church activities with the breakfasts and other fund raisers. It brings the Knights of Columbus concept closer to the other activities of the entire community outside the scope of our own church.

I also understand by the reports I hear from the wives who accompany their husbands to the Fourth Degree ceremony, they are having a great time learning about what the Knights of Columbus do. Very interesting speakers and functions. In fact, some of the additional activities and extra-curricular events established by previous leaders have placed some high standards to follow. No wonder the Fourth Degree Exemplifications are becoming more and more meaningful.

## **Community Director Report**

Brothers, Because of the changes by Supreme for the service program categories, there have been some changes in what Councils need to do to qualify for the Columbian Award (part of the qualifications for Star Council).

Looking at the COMMUNITY service program category, the required activity is known as "HELPING HANDS". Supreme has made the qualifications for this activity very broad and flexible, to allow Councils to tailor their own activity for what is needed in their community. THIS ACTIVITY IS REQUIRED FOR THE COLUMBIAN AWARD. There are many suggested HELPING HANDS activities listed below, from the Supreme website. These are only suggestions. Anything that helps your community and its people can qualify. Many of the things Councils have already been reporting can qualify for this category.



If you have questions, please contact your State Community Program Director, Kent Purdy, at [purdalator2@gmail.com](mailto:purdalator2@gmail.com) or call me at 503-881-1244. One thing that your Council may not be doing is items 5 and 6. Wear your Council apparel at the event. Take pictures to record it. Use it as a recruiting opportunity! Let's get the word out about what we do! This can make recruiting so much easier. Men will want to join us when we are actively doing God's work in our communities!

### Here are your ACTION STEPS:

1. Contact leaders from local nonprofit organizations. Discuss how the Council and parish can best assist them in their work.
2. As a Council, generate program ideas that would benefit those less fortunate in the community. Efforts could include:
  - o Parish cook and/or serve food free at a local soup kitchen or parish hall. (This could be a good family activity.)
  - o As a Council, assist in cleaning and repairing the facilities of a local nonprofit organization (i.e., fixing broken tables, painting walls).
  - o Hold classes to teach trade skills (electrical, plumbing, carpentry, etc.).
  - o Organize collection drives for specific supplies such as blankets, backpacks, toiletries, and clothing.
  - o Raise money for a local soup kitchen, homeless shelter or other nonprofit organization through various events. Money could go toward the purchase of specific supplies and appliances, such as a new large freezer or dishwasher, or it could be donated in bulk.
  - o Prominently display promotional posters (which can be ordered through Supplies Online)
  - o Bulletin announcements
  - o Pulpit announcements
  - o Posting on your Council and parish website / social media pages
  - o Immediately after your event is finished, complete the *Community Report Form* (Forthcoming)
  - o At the end of the fraternal year, complete your **Columbian Award Application (#SP-7)**
3. Build public interest for the program! Promote your Helping Hands activities in your parish and larger community through a variety of efforts:
4. Conduct your Helping Hands program.
5. On the day of the event, wear Knights of Columbus-branded apparel and have the Council membership director set up a table with brochures and membership documents (including *Prospect Cards #921A*). Do not forget that this event is a recruiting opportunity!
6. Enlist a fellow Knight or community member to photograph the event.
7. To gain credit for your program, complete the associated reporting forms and submit them to the Supreme Council Department of Fraternal Mission. Remember to retain copies for your Council records.

## **State Retention Chairman** **Our Vocation of Fraternity**

“Now is the time. With the holidays approaching, we have a great opportunity to show our Fraternal support for our Brother Knights. To retain our members, we need to have some type of personal contact with them. Email is convenient but NOT personal. We need to have a personal connection with them. Often, we only communicate when it’s bill time.

### **That’s not fraternal, that’s financial**

I’m asking each of the Councils to coordinate a means to telephone or meet face to face with your members. It doesn’t have to be the GK or FS. Create a phone tree, distribute the names to your officers and program directors, then ask the proposers to call them or just ask for volunteers.

I suggest you invite your members to a Thanksgiving event or the Council Christmas party. It should be something fun where there is no pressure. During the invite, ask them how they and their families are doing. Ask them if there is anything the Council can do for them or if there is something they’d like the Council to do. Tell them about one of your projects that went well this year. Engage them in the conversation.

Report any incorrect contact information to your FS who then will, hopefully, update the Council Membership Management database and then contact the Retention Chairman to update the Council database. Don’t forget to follow up with that call after you get the new updated information. Be proactive!!”

## **Public Service Announcement—USE CAUTION**

Someone has been trolling church websites to get names and emails to run scams.

Recently, someone made up a fake email address for Fr. Edwin ([fredwin.stmarysalbany@gmail.com](mailto:fredwin.stmarysalbany@gmail.com)) and asked people to respond for a favor. They are initially getting email addresses from websites, and then sending their request to parish staff, and volunteers who lead ministries, etc... then if people respond they ask for iTunes card #'s in the amount of \$400 (or other amounts) to give to a cancer patient.

***This is NOT legit. Please DO NOT respond.***

**Please DO let us know if you receive the message.** They can get other emails from anyone who has posted their email in the bulletin, too, so let us know if this goes further. For example, they may make up fake emails for other staff members or parishioners and send scam emails under other names.

Keep in mind, our parish would never ask you to give us money information over email. If we did ask for gift cards, we would ask you to drop them off at the office.

### **Keep Christ in Christmas**

## NEW FAITH IN ACTION FRATERNAL PROGRAMS REPORT FORM (#10784)

Following the launch of the Faith in Action program model, a new form has been created that will allow reporting for most of the Supreme-recommended programs. This new form will replace 24 individual report forms, streamlining the number of forms Council Officers are expected to use. The electronic form is available by going to KOFC.ORG.

**RECOMMENDED BEST PRACTICES:**

- Submit one report form per program.
- This new form is an optional addition for any reporting on Featured Programs, Free Throw Championship, Soccer Challenge, Catholic Citizenship Essay Contest, or Keep Christ in Christmas Poster Contest, which each have their own report forms that are required to be submitted.
- Save copies of all report forms to assist with the completion of the Annual Survey of Fraternal Activity (#1728) and the Columbian Award Application (#SP-7).
- Use your Fraternal Leader Success Planner (#5033) to help document the number of programs, events, charitable hours, and distributions throughout the year.
- When calculating service hours, remember that family members and volunteers assisting the Knights can be counted towards your totals.
- Reporting should be done in whole numbers only – do not report fractions of hours or spare change.

### **Faith In Action—Through The Helping Hands of Knights**

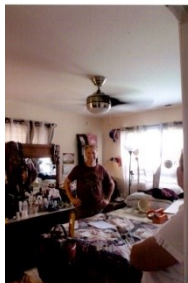
(Last month we had the story and this month we have the photos)
